### Relais Group Plc

We advised Relais Group Plc (“Relais”), listed on Nasdaq Helsinki First North Growth Market, when it acquired Raskone Oy for a purchase price of approximately EUR 30,000,000. We also advised Relais in the related share issuance carried out simultaneously with the transaction. The acquisition is a part of Relais’ growth strategy and supports Relais’ long-term financial targets.

### Cygnnet Holding Oy

We acted as advisor to Cygnnet Holding Oy (“Cygnnet Holding”) in a share transaction in which Cygnnet Holding sold a majority stake in logen Oy to OneMed Oy. The purchase price has not been disclosed. The transaction will be carried out in two phases as agreed in advance. Furthermore, the buyer-entity transferred its eye-surgery business in logen Oy as part of the overall transaction.

## **Relais Group Plc**

We acted as advisor to Relais Group Plc, listed on the Nasdaq Helsinki First North Growth Market, in its acquisition of the shares in Lemise Oy and Optisell Oy. The transactions were carried out as a combination of share issuances and cash. With the acquisition, Relais’ can accelerate its growth by utilizing digitalization, e-commerce solutions and data analytics.

## **Revenio Group Plc**

We acted as advisor to Revenio Group Plc (“Revenio”), listed on Nasdaq Helsinki, when it signed an agreement to purchase 100 per cent of the shares of Australian CERA Technologies Pty Ltd (Oculo). The acquisition is expected to close in the beginning of Q2/2021, provided that certain customary conditions are met. Additionally, we assisted Revenio in long-term incentive and securities market issue matters. The value of the acquisition is AUD 18,500,000, or approximately EUR 12,000,00.
