**Not so good vibrations**

A fine of £500,000 has been imposed in a recent case of hand arm vibration syndrome. This follows fines of £280,000 in 2016 and £120,000 in 2017. These cases serve as a stark reminder to all duty holders to revisit the measures in place to control the risks from the use of vibrating equipment.

**Brexit - Issues for the supply chain**

To date, much Brexit related reporting and news has focused on the impact on UK based businesses. Brexit is not however, merely a UK issue. Any business based outside the UK with a supply chain involving the UK will be impacted. A key concern is that many businesses will not even be aware that one, or more, of their supply chains involve the UK.

**Time to tune in to the risks**

A landmark ruling of the High Court has found that The Royal Opera House breached its health and safety duties, resulting in a viola player suffering acoustic shock during a rehearsal. Although this case was a civil action for damages, and indeed the first to compensate for acoustic shock, it looked at the duty on employers under The Control of Noise at Work Regulations 2005.

**Linked organisations: Sharing is Caring**

At first glance, the Health and Safety Sentencing Guideline appears to allow the Courts the ability to pierce the corporate veil and go beyond the corporate entity to be sentenced when assessing the relevant size of the offender to be punished. Should those in complicated group structures, or under the ownership of rich international organisations, be concerned? Nearly two and a half years on from the introduction of the Guideline, learn how the courts have been approaching this issue.

**Work place fatalities**

On 4 July 2018, the HSE published its annual workplace fatality figures which show that there has been a 6.6% increase in the number of workers being fatally injured at work. In actual numbers, this means that 144 individuals were recorded as having died as a result of a workplace incident in the year between April 2017 and March 2018, compared to 135 the previous year.

**Medium Combustion Plant Directive**

We consider the impact of the Medium Combustion Plant Directive and the new requirements on such plants, including generators. This is relevant to anyone operating particular combustion plants including generators and affects a whole range of sectors.

**Looking after those on the road**

The latest statistics released by the Health and Safety Executive highlight that the 'Transportation and Storage Sector' have a rate of fatal injury around 1.5 to 2 times the average rate across all industries. This is worrying news, particularly in light of a recent warning from Unite around the ageing workforce driving heavy goods vehicles around the country.
